This newsletter is to update you about progress with the Boston Barrier tidal flood defence project. The barrier is part of a phased approach to reduce the risk of tidal flooding to 20,000 properties in Boston over the next 100 years.

New information about the Boston Barrier



Modelling flows in the Haven


We have been modelling the impact of the barrier on flows in the Haven and meeting with river users to discuss this.

The graphic on the right shows the average maximum flows in the Haven with and without a 25 metre barrier in place. The colours are used to show the speed of river flows in knots. Dark blue represents the lowest flow speeds and red represents the highest flow speeds. So you can see in the example opposite there will be no significant change in the velocity of river flows during average flows as a result of the barrier.

We will continue to meet with river users to discuss this in more detail – including how we plan to maintain navigation during construction of the barrier - on the run-up to submitting the Transport and Works Act Order Application in spring 2016.

Appointing a construction partner

This month we have been meeting with prospective companies to talk about the detailed design and construction of the Boston Barrier. We have been inviting suppliers to Boston discuss the project and answer questions before the formal tendering process begins.

We aim to have a contractor on board by summer 2016 so that we can start detailed design for the when the Transport and Works Act Order application is submitted. This will allow construction to begin as soon as possible - subject to the necessary approvals being in place.

Key dates for the Boston Barrier

- Spring 2016 submit Transport & Works Act Order application
- Summer 2016 design and build contractor starts detailed design work.
- Late 2017 construction of Boston Barrier and associated works starts.
- December 2019 construction of Boston Barrier and associated works is completed.
